Motion was made and seconded by Scott Herbst/Carol Neubert to approve \$64,573.17 in checks paid from the Borough's General Fund, of which \$51,500.44 is the Borough's portion of the expense and \$13,072.73 the Authority's portion of the expense. In addition, decrease adjustments in October from the Borough General Fund in the amount of \$35,133.65 of which \$15,294.83 was the Borough's

portion of the expense and \$19,838.72 was the Authority's portion of the expense, and payroll for October 2021 in the amount of \$80,217.92 of which \$31,043.33 is the Borough's portion of the expense and \$49,174.59 is the Authority's portion of the expense. The motion carried with Pat Rinebolt abstaining due to business before the Council.

2022 Budget

Mary presented the Park and Borough budgets with Council's agreed upon changes.

 Scott said, according to Fred [Caesar], the next thing to do with the Wire Rope Shop is to have an engineering study done. He asked if the funds from the old Park account could be used to pay for the study in lieu of moving the \$30,000 from Capital Expenses to the Park.

Mary explained that a portion of those Park account funds were already promised to the Borough for gazebo roof work. She further explained that the \$30,000 is on a line item on the budget which allows Council to reallocate it at any time as it is not designated nor restricted.

 Dave asked how much the tax assessment appeals by the nursing homes in Saxonburg will affect the Borough's budget.

Mary explained they will continue to reduce the Real Estate revenue, but we don't know by how much.

• Scott asked why Mr. Pickard is listed on the budget as the tax collector.

Mary explained that, though we don't know who will be collecting the taxes in 2022, the expense is still there.

Motion was made and seconded by Dave Felsing/Pat Rinebolt to advertise the 2022 Budget as presented. The motion carried.
