Audubon Nelson Milano

Mr. Milano confirmed the trees are Callery pear and are invasive. A list of native replacements has been provided though the grant cycle for this year has too narrow of a window for this summer for the Borough to apply as bids and proposals would need to be made by the first week of April. The Audubon Society has several programs including grant writing services that the society will keep us informed of as the Borough progresses through this issue. Native trees that would be provided through grants would need to be "hole ready", meaning they would need to be planted immediately once received.

Museum Curator Fred Caesar

Mr. Caesar reports that the museum collection has grown about 1/3 over the past 5-7 years. New displays include the sign from the Lassinger storefront, now 319 W. Main Street, and a handmade fiddle from the late 1800's specifically earmarked for the Saxonburg Museum from the Maynard Family. Tours continue to be booked through <u>saxonburgmuseum@gmail.com</u>. A recent tour with adults from LifeSteps left Fred touched by their enthusiasm. Fred has been asked by the Butler Eagle to write articles for their America 250 April special as well as the papers Business Matters section regarding John Roebling and the evolution of Main Street.
